Module Description

♣ This is a 2 day Home-Based Isolation and Care training that is prepared for frontline Health Care Workers involved in HBIC. It enables participants to address patients in HBIC according to the guideline during assessment, enrollment, follow up, referral and discharge.

Module Goals

♣ To provide participants with the Knowledge, Skill, and Attitude required for HBIC during assessment, enrollment, follow-up, referral, discharge and reporting.

Participant Learning Objectives

- Translate the implementation guideline into practice.
- Identify patients who are eligible for HBIC
- Practice the appropriate Basic hygiene and IPC protocol during implementation of HBIC
- Classify patient who are high risk during follow-up.
- Engage actively in the Health Education and Community Engagement
- Practice the up-to standard follow-up of enrolled patients
- Practice the appropriate protocols during referral linkage and patient transfer to treatment centers
- Analyze the available data of enrolled HBIC patients.
- Interpret and propose an action plan for possible intervention.
- Monitor and evaluate the implementation process.

Participant selection criteria

- Participants for this course are expected to fulfill the criteria's that are listed below:
 - Health professionals [medical doctor, health officer, nurse, health extension workers]
 - o Currently engaged or will be engaged either directly or indirectly on HBIC system

Method of Evaluation

Participants

Formative

- Pre-test
- Evaluation of activities while carrying out procedures (Directly observed practice/DOP)

Summative

- Knowledge assessment (60%) Post-course Assessment
- Participant procedure performance (DOP) (30%)
- Class participation (10%)

Certification Criteria

 Participants will be certified when they score above 60 in the post test and when they full fill 100% attendance

Course

- Pre-course participants' expectation
- Daily evaluation
- End of course evaluation
- Daily meeting for feedback evaluation by trainers

Trainer selection criteria

- Currently working in COVID-19 Clinical Case Management response preferably those working on HBIC
- Trained in Facilitation Skill and has experience in facilitation training skills course
